## Development & Implementation of a comprehensive dairy workforce training program

**Need:** average herd size of New Mexico dairies is roughly ten times the U.S. average herdsizes. Effective training and development of current and future employees is imperative. Middle management development is becoming increasingly important. **Program goal:** improve employee performance metrics.

**Program impact:** approximately 7,500 employees have been trained on dairy safety and animal handling. Training is provided in a preferred language (English, Spanish, or K'iche). Training effectiveness is a key evaluation metric. Due to processor and customer demands, National Milk Producers Federation (NMPF) created a Workforce Development Task Force (2017), which developed a Dairy Safety Reference Manual in English and Spanish (Doughrath and Hagevoort, 2019). Idaho Dairymen's Association (IDA) adopted the training program in 2018 with significant processor and co-op support. Dairy West (ID & UT) in 2023 decided to implement a workforce development program utilizing these resources. NMSU's dairy workforce development is considered an industry leading example, with program details utilized on some of the largest US dairy operations. Additional modules added: Fitness to Transport (2022), Maternity & Calf Care (2022), Feeds & Feeding (2020). Combined YouTube views of [video library](#) (12/23) is 168K total, or over 20,000 views/year, view count up 25% from 2022. - One third of New Mexico dairy workforce trained

- NMPF created Workforce Development Taskforce (2018)
- Taskforce developed Dairy Safety Reference Manual (2019)
- Module Feeds & Feeding developed with Diamond V (2019)
- Feeds & Feeding released on mobile devices for training (2020)
- Maternity & Calf Care developed with IDA (2022)
- Fitness to Transport developed with FARM & Elanco (2022)
- Dairy West implementing program based on developed resources (2023)
- CCQA (Calf Care Quality Assurance) being developed (2023-2024)
