


Success Stories

Let's Be Proactive

- Field Days / Field Trips
- Educate to create awareness
- Invite your neighbors
- Harvest Parties
- Send notices to your neighbors when harvesting
- Letters to the editor (notice of dust during harvest, shed a positive light on the industry, use science)
- Roadside signs



Tools, Tips & Resources

- Right to Farm Act
- Pecan Theft Legislation "Pecan Buyers Licensure Act"
- Get involved with local governments & elections
- Land Use Planning
- Know your state elected officials
- Farm Bureau, Extension Services, other Commodity Trade organizations
- Develop a PR plan for issues mitigation
- Identify someone who can/will address the media

How to Respond

- "We understand your concern" and explain why it is happening
- Develop a key message, stay focused, and repeat them frequently
- Keep answers brief when talking to media
- Say only what you want to say then stop
- Avoid jargon and acronyms
- Block and bridge to refocus interview or address difficult questions
- And remember you are never "off the record"
- Send letters to neighbors Better proactive strategy than reactive
